

StonkBrokers Protocol — Business Source License 1.1

Official licensing notice from **SB (BVI) Ltd**. This document states license terms only — **it does not include protocol source code**.

1. Status

SB (BVI) Ltd licenses the **StonkBrokers Protocol** Licensed Work under the **Business Source License 1.1 (BUSL 1.1)** — the same source-available model Uniswap uses for v3/v4 core and SB (BVI) Ltd uses for **Anvil AMM** — so partners and builders can receive source under clear rules without a free-for-all production clone window.

Warning to cloners and violators. Production or commercial use of StonkBrokers Protocol source — including deploying a competing Clock In engine, Smart Launch / Safe Launch pad, Broker Box machine stack, collection / marketplace derivative, or other Licensed Work fork — without an Additional Use Grant or written commercial license from SB (BVI) Ltd **violates BUSL 1.1**, terminates your license rights, and may be pursued as copyright infringement. On-chain bytecode, Blockscout verification, public ABIs, and integration PDFs are **not** a production-use grant.

3. What you may / may not do

Allowed under BUSL (without a grant)	Not allowed without a grant / commercial license
Non-production study, research, internal testing, and modification of source you lawfully received under this license.	Production or commercial use — including deploying a competing Clock In, launchpad, Broker Box, marketplace, or AMM stack derived from the Licensed Work.
Integrating against live Clutch-operated StonkBrokers / Anvil / Clock In / Smart Launch deployments via public ABIs as an end user or frontend.	Using StonkBrokers / Clock In / Smart Launch / Anvil / Clutch trademarks, or rebranding a clone as official.
Holding Additional Use Grant rights if your entity is listed in the grant register.	Assuming partner talks, Discord chats, or “open source on GitHub” equal a grant — grants are written and listed.

End users and integrators: Trading, launching, clocking in, or building a wallet / terminal that talks to SB (BVI) Ltd' live contracts is fine. Copying those contracts into your own production factory is not — unless you have a grant.

4. Anvil AMM (related)

Anvil AMM factory, vaults, deployers, and related protocol source are licensed under BUSL 1.1 in the SB (BVI) Ltd **Anvil** repository. Same Licensor. Same production restriction. See Anvil `LICENSE` , `contracts/licenses/BUSL_LICENSE` , and the Anvil BUSL notice PDF.
